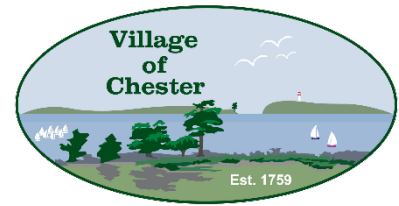

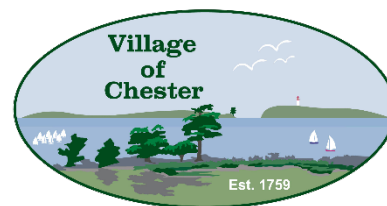

## Tourism & Economic Development

Short-term	<ul style="list-style-type: none"> <li>• <b>Visitor Information Centre (VIC)</b> – temporary location Summer 2025 – consult with Chester Merchants Assoc (CMA)</li> <li>• Satellite VIC at Village office – front room and/or rack on steps Summer 2025</li> <li>• <b>Investigate shuttle bus transport</b> from Hwy 3 parking to downtown – consult with CMA</li> <li>• <b>Directional signage</b> – research re: locations, lettering (NS Public Works), permitting, cost, design, etc.; focus on directions to downtown, golf course, rink (wayfinding consultant?)</li> <li>• Install large “Lido Pool” sign at Parade Square</li> </ul>
Medium	<ul style="list-style-type: none"> <li>• Visitor Information Centre (VIC) – permanent location (Hwy 3? train station? ferry dock?) – building or kiosk &amp; portable washroom</li> <li>• Directional signage installation</li> </ul>

## Recreation

Short-term	<ul style="list-style-type: none"> <li>• Phase 3 of Lido accessibility retrofits (parking lot to pool deck) – source funding</li> <li>• Investigate Jib Lot ideas – accessible patio, terracing/landscaping, moorings in water lot (confirm boundaries)</li> </ul>
Medium	<ul style="list-style-type: none"> <li>• Bike racks?</li> </ul>
